What are we doing?

At the end of November until mid-December 2023, there will be traffic management at the junction of Station Road, Fiddlers Field and Quainton Road to complete water main connection works.

When will these works take place?

The junction of Station Road, Fiddlers Field and Quainton Road will be controlled at the crossroads by three way temporary traffic lights from Monday 27 November to Sunday 17 December 2023, 24 hours a day.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Duration of works

There will be three way traffic management at the junction of Station Road, Fiddlers Field and Quainton Road between Monday 27 November and Sunday 17 December 2023, 24 hours a day to complete water main connection works.

Three way traffic lights on the junction at Station Road, Fiddlers Field and Quainton Road.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

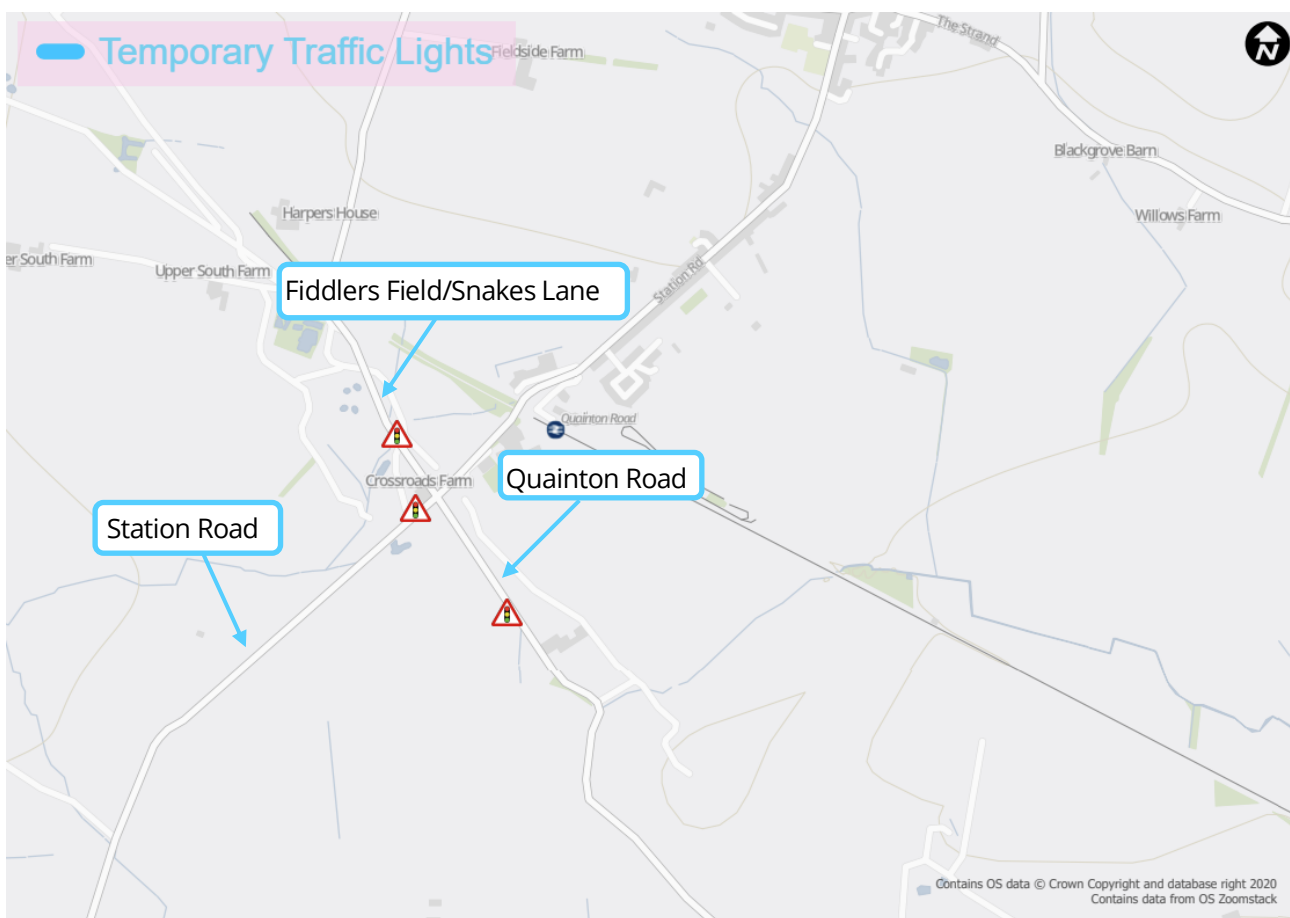
