What are we doing?

Along the A418 we need to undertake some urgent maintenance in the wooded area along the northern side of the A418 Oxford Road.

Following an incident where a tree branch fell into the live carriageway due to high winds in the area, we have surveyed the immediate trees and vegetation and identified a selection that require immediate maintenance to prevent any further incidents, before the onset of any further bad weather.

This will involve the removal of any overhanging branches near the road and footpath and the limited removal of some trees where necessary for public safety reasons.

We will install temporary traffic lights to create a lane closure where we can work safely.



When will these works take place?

• Monday 11 December and Tuesday 12 December between 09.30am and 3pm.

These works have been scheduled to take place outside of peak hours to cause minimum disruption to road users.

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Duration of works

Lane closure in place between 09.30 and 3pm – Monday 11 December, and Tuesday 12 December 2023.

You may see our traffic teams setting out equipment before the times where the lights are active.

What to expect

Lane closure along the A418 Oxford Road with temporary traffic lights. Increased travel times.

What we will do

Minimise disruption as much as possible for the community.

Provide updates for communities and maintain regular contact with emergency services.



Where are the works taking place?

We will be working on the northern side of the A418, opposite the A418 compound between the Coldharbour roundabout and the Mayflower Close.

Before any vegetation removal, an ecologist will complete a detailed survey of the area to be cleared. Any protected species found to be present will be recorded and the vegetation will be left undisturbed with the appropriate buffer zone established.

Vegetation clearance will only commence once further surveys and mitigation can be established to confirm that the protected species are no longer present.
