

Notice of overnight road closures, A43, Brackley BP roundabout to the Syresham junction

High Speed Two (HS2) is the new high speed railway for Britain. EKFB is working in partnership with HS2 Ltd to build the new high speed railway in your area. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

In the middle of June, we will be carrying out maintenance of the verges along the A43. Some of our signage is becoming increasingly covered by foliage which has grown larger after winter.

To minimise the impact to road users, these works will be carried out under overnight road and lane closures. We will also be utilising these overnight closures to update road markings that are showing signs of wear.

We will continue to collaborate with National Highways and update local communities on the progression of our works.

When will these works take place?

The **A43 Northbound** towards Northampton, will be fully closed overnight, from the Syresham Junction to the Brackley BP roundabout, from 8pm Monday 17 June to 6am Tuesday 18 June. During this time, there will be a single lane closure on the A43 Southbound.

The **A43 Southbound** will be fully closed overnight towards Oxford, from the Syresham Junction to the Brackley BP roundabout, from 8pm Tuesday 18 June to 6am Wednesday 19 June. During this time, there will be a single lane closure on the A43 Northbound.

As a contingency, should our teams be unable to complete the above works due to circumstances outside of our control such as weather, works will be carried out on the following dates:

- A43 Northbound overnight closure – From 8pm Monday 24 June to 6am Tuesday 25 June.
- A43 Southbound overnight closure – From 8pm Tuesday 25 June to 6am Wednesday 25 June.

Duration of works

The **A43 Northbound** towards Northampton, will be closed overnight for one night, from 8pm Monday 17 June to 6am Tuesday 18 June.

The **A43 Southbound** towards Oxford, will be closed overnight for one night, from 8pm Tuesday 18 June to 6am Wednesday 19 June.

What to expect

Overnight full road closures of the A43.

Speed restrictions on this section of the A43.

These dates may be subject to change due to circumstances outside of our control, such as weather.

These works are subject to consents.

What we will do

Respond promptly to any complaints and take appropriate action.

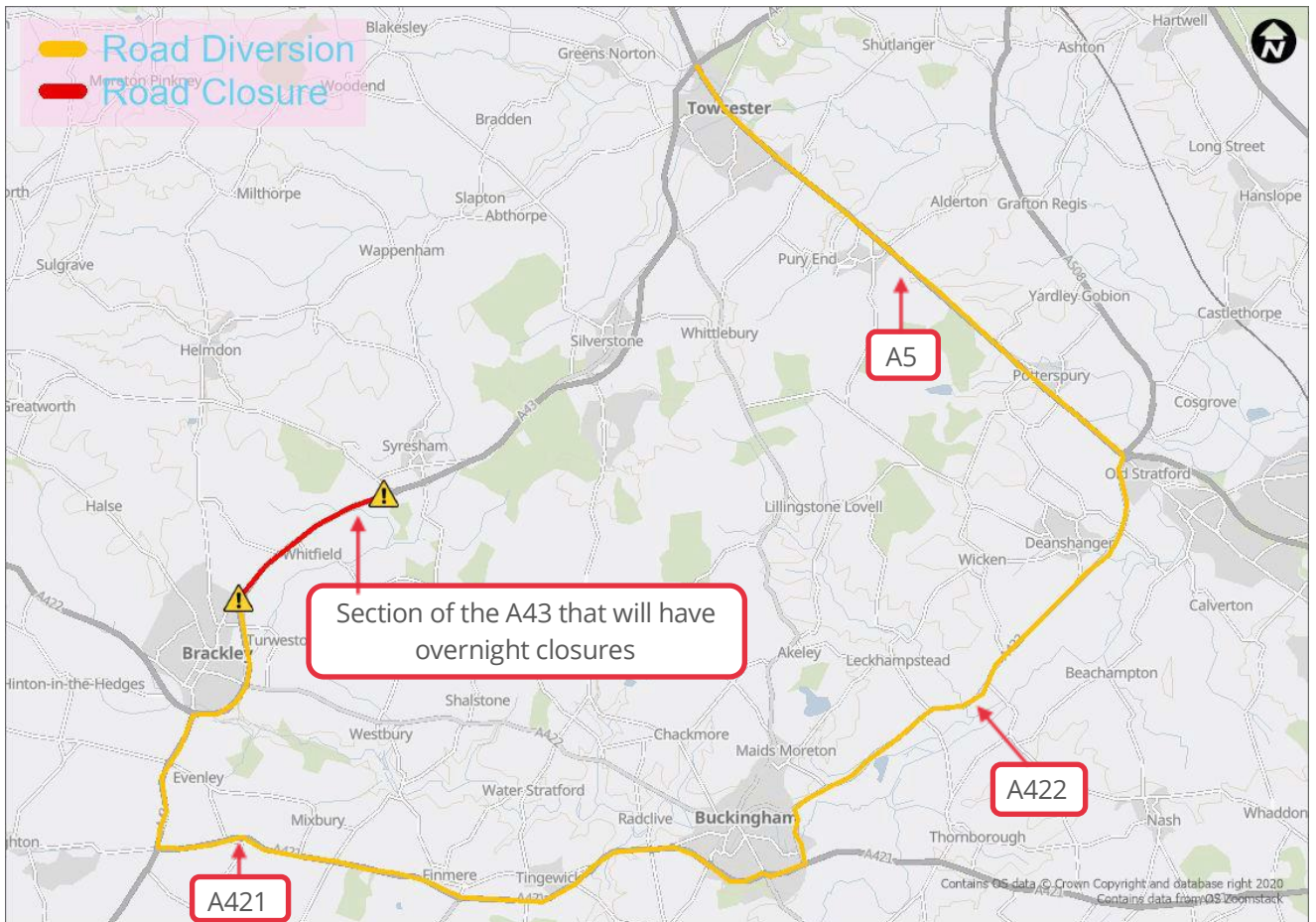

Where will the works take place?

The map below, shows the section of the A43 that will have overnight road closures from the Brackley BP roundabout to the Syresham Junction. The diversion route is via the A421, A422 and A5. These closures have been communicated to blue light services.

In addition to this notice, the road closure information will also be communicated through traditional road signage as well as electronic signage. These signs will be located in strategic locations and placed in a safe location. We would remind all road users to plan their journeys, allow more time and follow the signed diversion routes.

For the safety of road users and our workforce there will also be speed restrictions on this section of road. Periodic overnight lane closures will continue along this section of the A43, northbound and southbound, allowing us to progress our works for the A43 Overbridge.
